**Decommissioned abandoned wells and installed a spill containment facility to prevent contamination of ground and surface water.**







## TREES ARE AN INVESTMENT

Trees are an ongoing effort to make a successful planting. Though a lot of work, the reward is worth it. It is what you make of it.

It starts with tree planning and selecting the best soils possible, plus the right trees for the right soil. Then it's up to you the producer to work the location into a garden like atmosphere.

Tillage with a minimum of 6 inches, free of all sod and weed. Tillage should be done 1 year prior to planting and should be reworked in the spring of the year. A tractor is required to pull the tree planter, but not the weed barrier machine.

Trees should be straightened and packed after trees are installed. It takes a little time but it improves the chances of survival. After trees have been stomped the ridges should be driven down either with a small tractor or a four wheeler, the ground should be ready for weed barrier if being applied.


Watering of the trees is a big plus right after planting and during the season.

Warm season grasses could be planted between the rows with weed barrier for cooler soil temperatures and taller grasses for wind protection and snow catch.

Trees should be kept clear of grasses and weeds, even with weed barrier some grasses will grow at the trunk of the trees.

If located near any good water source drip emitters are good investments.

**We do staking of plots and tree rows if you need help with the design.**

This structure worked very well when NRCS staffing levels were static. However, as the staffing levels have changed, NRCS was forced to look at alternative methods for servicing its customers. Locally, the Beach, Killdeer and Dickinson field offices were combined to create the Badlands Conservation Delivery Unit. The field offices in Beach, Killdeer and Dickinson will all remain open, and the staff in these offices will be working together to implement conservation practices and programs.
